#### **Our Financial ability:**

Likewise, we have saved CAD 60,000 in our bank accounts which are openly accessible to me and I have been authorized by my husband to use these savings towards my mother's visa and living expenses. I couldn't be more thankful to him for this lovely gesture. Please find enclosed the proof of our financial ability to fund my mother's trip and stay in Canada without running out of cash. I hereby, assure you that I and my husband are the sole ties for my mother here in Canada. Despite us, there is no one with whom she shares any family ties in this country.
